Gov. Mary Fallin (R)

- ❖ 75.2% of persons without disabilities aged 18 to 64 are employed.³
- ❖ 35.8% of PwDs aged 18 to 64 are employed.³
- ❖ 594,417 persons in OK have a disability.³
- ❖ 17,700 persons aged 16 to 20 have a disability.¹
- ❖ 301,500 persons aged 21 to 64 have a disability.¹
- ❖ 56,200 PwDs aged 18 to 64 receive benefits.¹
- ❖ Voc. Rehab received 7,580 applicants in OK in 2012.³
- ❖ Voc. Rehab. obtained 3,106 jobs for PwDs in OK in 2012.³
- ❖ In 2012, OK's total expenditure on SSDI benefits was \$1,798,200,000.³

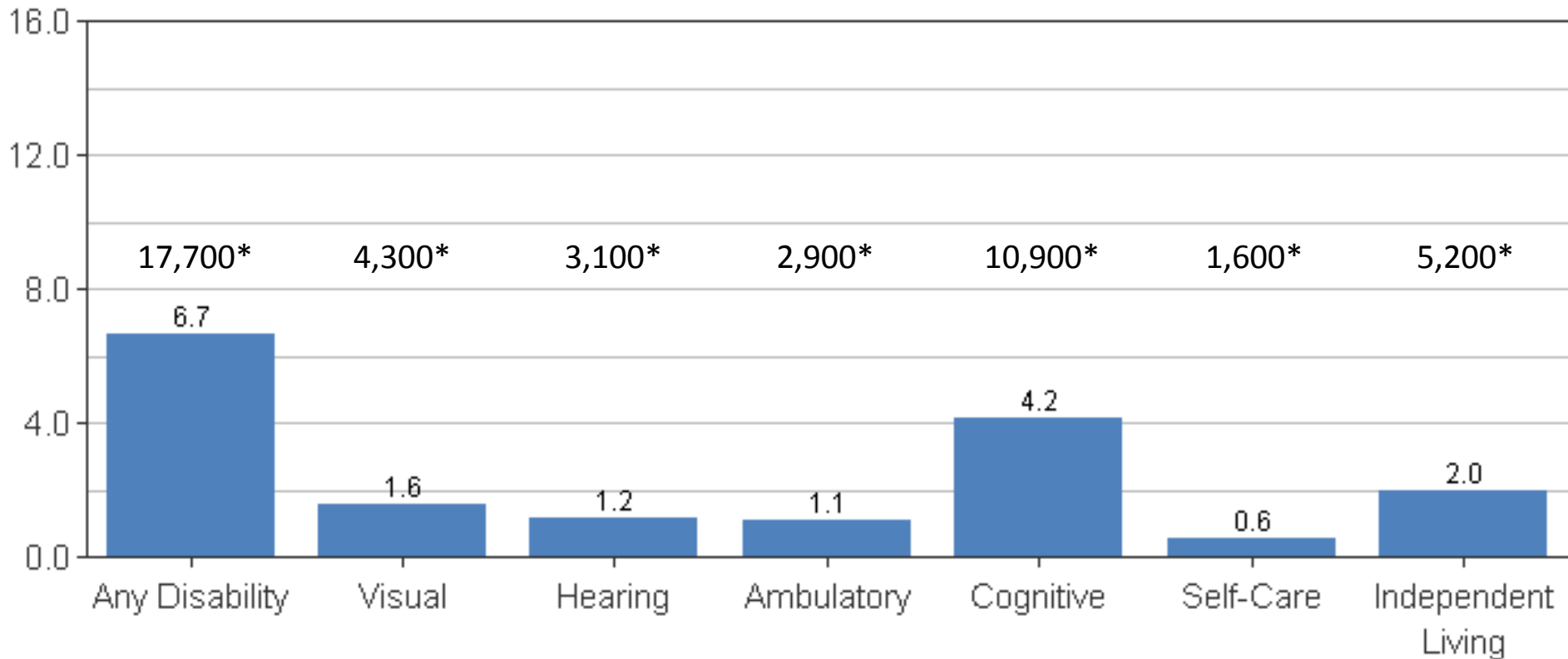

Prevalence Rates: Age 16 to 20 years (%)

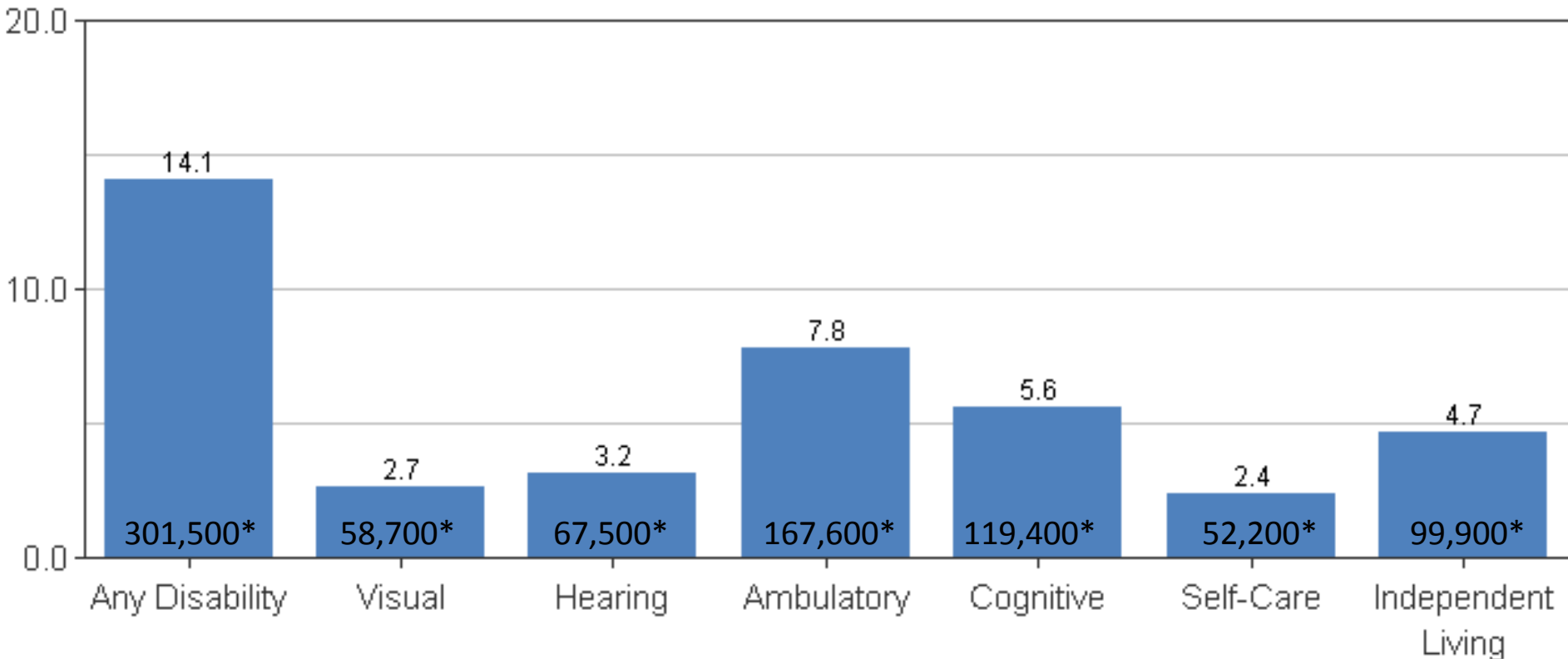

Prevalence Rates: Age 21 to 64 years (%)

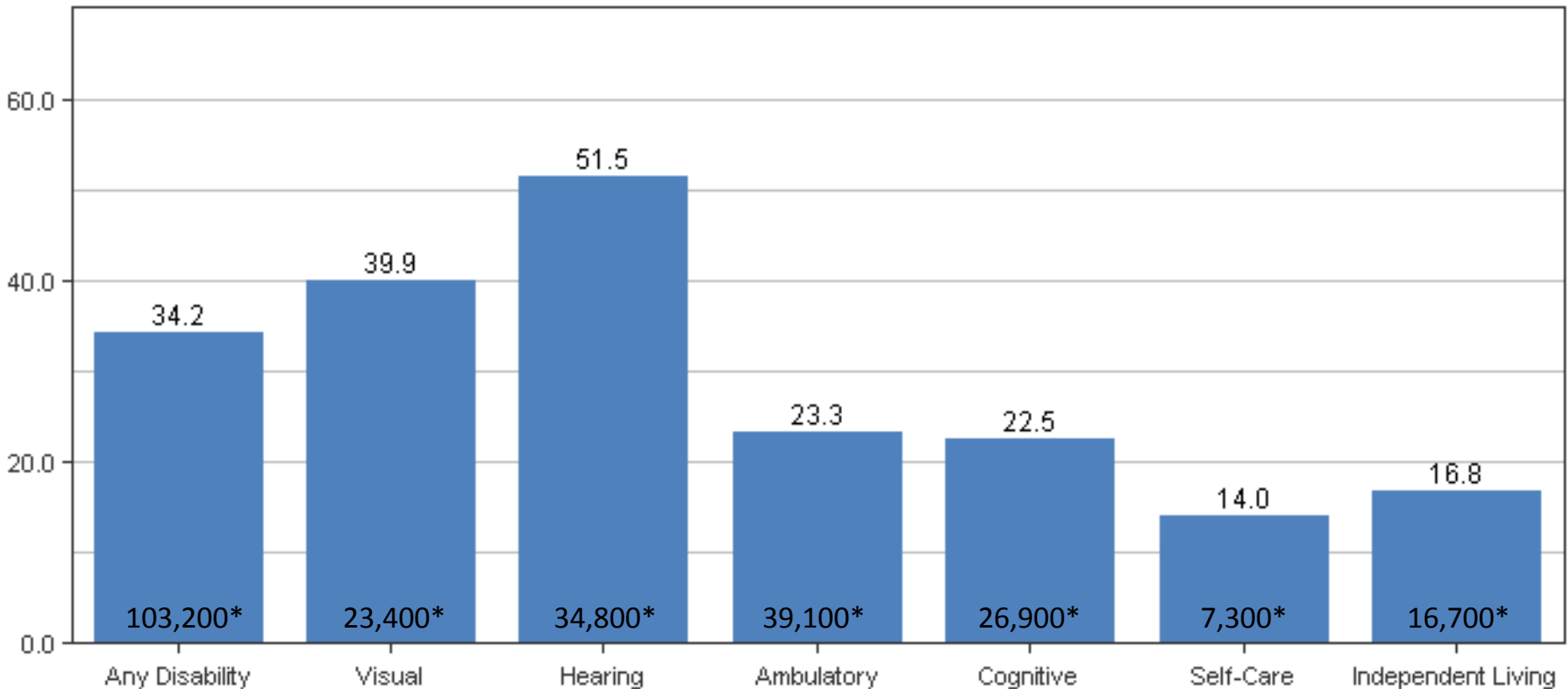
